Tarr opened the Budget Hearing and Budget Summary Public Hearing at 5:37

Carmen Standley with HBE. discussed with the Board the 2023-2024 Budget documents with the Actual Numbers and Projected Numbers. With no other comments or concerns from the Board and no visitors present, Tarr moved to close the Public Hearing for Budget Summary at 6:00 p.m. Lemkau seconded the motion.
