Booster Pump Inspection and Backflow Prevention Requirement

The Village of Malcolm is requesting your assistance in identifying any residential properties that have a **booster pump** installed as part of their water system.

In accordance with regulations set by the **Nebraska Department of Environment and Energy (NDEE)**, all booster pumps must be equipped with an approved **backflow preventer** to protect the public water supply from potential contamination. Additionally, the Village is required to maintain documentation of these installations for compliance purposes.

If you currently have a booster pump in your home, please contact the **Village Office at 402-796-2250 or clerk@malcolm.ne.gov** at your earliest convenience. Our maintenance team will need to perform a brief inspection to confirm that the required backflow prevention device is properly installed and functioning.

We appreciate your prompt attention to this matter, as your cooperation is essential in helping us ensure the continued safety and quality of our community's drinking water.

Dogs Applications

All dogs residing within the Village of Malcolm corporate limits were required to be licensed or have their licenses renewed by June 1, 2024. If you have misplaced your application, you may download a new one from the Village website at www.malcolm.ne.gov, or request one by contacting the Village Clerk at (402) 796-2250. Please note that a non-returnable copy of a current rabies vaccination certificate must be submitted with your completed application.

Boats, Trailers and Campers Parked on Streets

Per Malcolm Municipal Code Chapter 4, Section 4-302(a), it is a violation to leave a vehicle parked on any public street for more than 24 hours. Vehicles left beyond this timeframe may be considered a nuisance and pose a safety or health hazard.

Under Section 4-311, violations are considered misdemeanors and are subject to fines of up to \$500 per offense, with each 24-hour period constituting a new violation. In lieu of court, fines of \$100 for a first offense and \$150 for a second offense within a calendar year may be paid directly. Additional offenses require a court appearance. Please ensure all vehicles are moved within the 24-hour limit to remain in compliance with Village Code.

Weed Control and Grass Clipping Reminder

In accordance with **Malcolm Municipal Code Chapter 6, Section 412**, property owners are responsible for keeping their property—and one-half of the adjacent streets and alleys—free of weeds and overgrowth exceeding **12 inches**. All cut vegetation must be **immediately removed**. If not addressed within **five (5) days of notice**, the Village may clear the property and assess the cost to the owner.

Additionally, please **avoid mowing grass clippings into the streets**, as this creates safety and maintenance issues. Many communities issue fines for this—let's work together to keep Malcolm clean and avoid such measures.
